- Whereas : Based on the application of I Made Puryatma, SH, Notary Public, number 31/NOT/DPR/2008, dated March 03rd, 2008 on the application for an Approval of a Foundation and Number 122/NOT/DPR/2008, dated June 13th, 2008 on the Approval for Yayasan Anak Bali, received on September 05th, 2008;
- Whereas : After the investigation of the Deed of Foundation Establishment delivered to the Ministry of Law and Human Rights of the Republic of Indonesia, it is certified that the Deed is qualified under the applicable statutory regulations and is therefore approvable;
- Keeping in mind : 1. Law Number 16 of 2001 on Foundations (Republic of Indonesia State Gazette of 2001 Number 112, Supplement to Indonesian State Gazette Number 4132), in conjunction with Law of the Republic of Indonesia Number 28 of 2004 on Amendment of Law Number 16 of 2001, on Foundations (Republic of Indonesia State Gazette of 2004 Number 115, Supplement to Indonesian State Gazette Number 4132), in conjunction with Law of the Republic of Indonesia Number 4430);
2. Decree of the Director General of Administration of

Common Laws, of the Ministry of Law and Human Rights of the Republic of Indonesia Number C-26.HT.01.10.TH.2004, dated December 06th, 2004 on the Procedures for Approvals of Deeds Establishment and Approvals for Amendments to a Foundation's Articles of Association;

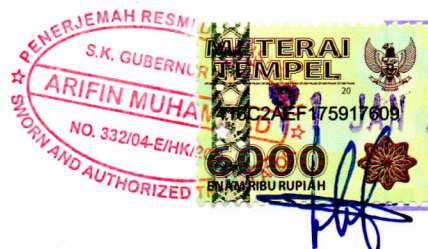
SECOND : This Decree shall be effective as of the date of its issuance.
